Agenda item 2.1. Adoption of the agenda

Agenda item 2.2. Approval on attendance of observers

Agenda item 3.1. Lloyd's Register Quality Assurance Limited (based on their new accreditation under the ISO 14065)

The JC considered the application for designation as a Third-Party Entity submitted by Lloyd's Register Quality Assurance Limited (LRQA)based on the new accreditation under ISO 14065(validation and verification functions in sectoral scopes: 1-15) and decided to designate LRQA as a TPE as submitted.

Agenda item 4. Interim special measure for the on-site assessment by TPEs

In the midst of the COVID-19 pandemic, Third Party Entities (TPEs) and project participants have been facing difficulties regarding the on-site visits conducted by TPEs. In consideration of such circumstance, the JC considered the interim special measure to ease requirements on an on-site visit of the first verification by TPEs as a temporary measure and adopted it effective from 28 March until 31 December 2022.

Requests for issuance that attach the verification report applying the interim special measure for on-site assessment will be assessed by the JC.

Agenda item 5. Issuance of JCM credits

Agenda item 5.1. Installation of High Efficiency Centrifugal Chiller for Air Conditioning System in Clothing Tag Factory in Bangladesh (BD002)

The JC considered the request to notify each side to issue credits by the project participant of

the project BD002 "Installation of High Efficiency Centrifugal Chiller for Air Conditioning System in Clothing Tag Factory in Bangladesh" for the monitoring period from 1 March 2017 to 31 July 2019. The JC decided to notify each side of the amount of credits to be issued using the notification form.

Agenda item 5.2. Introduction of PV-diesel Hybrid System at Fastening Manufacturing Plant (BD004)

The JC considered the request to notify each side to issue credits by the project participant of the project BD004 "Introduction of PV-diesel Hybrid System at Fastening Manufacturing Plant" for the monitoring period from 1 June 2016 to 31 July 2019. The JC decided to notify each side of the amount of credits to be issued using the notification form.

Agenda item 6. Other matters

Agenda item 6.1. Promoting development of JCM projects and methodologies in Mongolia

The Japanese side shared the current status of JCM projects and projects in the pipeline and also explained the financing programme for the JCM, including the JCM Model Projects, the Japan Fund for the JCM by Asian Development Bank, the JCM F-gas recovery and destruction model project, and the NEDO Demonstration Program.

The Japanese side also explained the capacity-building activities on the JCM implementation under Article 6 of the Paris Agreement and various project development activities including the online JCM business matching site "JCM Global Match".

Both sides discussed the opportunities and challenges of the JCM implementation and consented to strengthen the communication among stakeholders.

Agenda item 6.2. Arrangements for implementation of the JCM in line with Article 6 of the Paris Agreement

The Japanese side explained an outline of Article 6 rules of the Paris Agreement, particularly guidance on cooperative approaches referred to in Article 6, paragraph 2, agreed at COP26, and a proposal of further revision on rules and guidelines of the JCM consistent with those rules. The JC consented to initiate consultation between the Bangladesh side and Japanese side through the secretariat for revising the rules and guidelines of the JCM with a view to adapting those revisions at the next Joint Committee.
