Agenda item 2.1. Adoption of the agenda

The Japanese side explained the overview of the JCM, the JCM model projects and the JCM demonstration program.

Agenda item 4. Extension of the JCM

The JC discussed extension of the partnership for the JCM beyond a coming into effect of a new international framework under the United Nations Framework on Climate Change. The JC decided to extend the partnership until 2030.

Accordingly, the JC decided to modify the related paragraph of the bilateral document, "Low Carbon Growth Partnership between the Japanese side and the Ethiopian side".

Agenda item 5. Rules and guidelines

Agenda item 5.1. Revisions related to possible extension of the JCM

The JC considered the draft revisions to "Rules of Implementation for the Joint Crediting Mechanism (JCM)", "Joint Crediting Mechanism Guidelines for Developing Project Design Document and Monitoring Report", "JCM Verification Report Form" and "JCM Credits Issuance Request Form" and adopt them, as contained in <u>Annex 1, 2, 3 and 4</u> to this meeting report.

Agenda item 5.2. Common Specifications of the JCM Registry

The JC considered the draft "Common Specifications of the JCM Registry" and decided to adopt it, as contained in <u>Annex 5</u> to this meeting report. Requested by the Ethiopian side, the JC also took note of the importance of capacity building regarding the registry.

Related to the Agenda item 4 and 5, the JC confirmed to approve the meeting report of the Third Joint Committee meeting (JC3).

Agenda item 6. Third-Party Entity

Agenda item 6.1. Japan Management Association (addition of sectoral scope)

The JC designated Japan Management Association (JMA) for the additional sectoral scopes of 1, 2 and 3 for verification.

Agenda item 6.2. EPIC Sustainability Services Private Limited (addition of sectoral scope)

The JC designated EPIC Sustainability Services Private Limited for the additional sectoral scope of 12 for validation and verification.

Agenda item 7. Other matters

Agenda item 7.1. Promoting development of JCM projects in Ethiopia

The Japanese side explained the overview of a pipeline JCM project.

The Japanese side also explained the comprehensive programmes of JCM-related support, including an online JCM business matching site "JCM Global Match", memorandum of cooperation between the World Bank and the Ministry of the Environment, Japan and the city to city collaboration program.

Agenda item 7.2. Application for CORSIA

The Japanese side explained the Carbon Offsetting and Reduction Scheme for International Aviation (CORSIA) under the International Civil Aviation Organization (ICAO). The JC consented to further discuss a possible application of the JCM for the scheme.

The Co-Chairs gave closing remarks and closed the meeting.
