Co-Chairs requested to take 10 working days as probation period before making the JCM-REDD+ guidelines come into effect. The JC decided to make the adopted guidelines publicly available after the period, which was dated to be 14 June 2018.

Agenda item 4. Issuance of JCM credits

The secretariat explained the procedure for processing request for issuance of credits. The JC discussed the basic principle on how credits are allocated among project participants and both sides in line with the rules and guidelines of the JCM. The Japanese side explained the conditions for credit allocation pertaining to the financing programme for JCM model projects through which the Ministry of the Environment, Japan provides financial support of less than half of the initial investment for projects and would like to request for at least half of the JCM credits to be issued to the Japanese side. The Cambodian side requested further consideration and discussion on credit allocation among project participants and the host country.

Agenda item 5. Other matters

Agenda item 5.1. Promoting development of JCM projects in Cambodia

The Japanese side explained the financing programme for JCM model projects, ADB Trust Fund (Japan Fund for the JCM: JFJCM) and updated information on the projects which are currently implemented in Cambodia under these financing programme.

Agenda item 5.2. Introduction of the REDD-plus project in Prey Lang

An observer organization gave a presentation on their potential REDD-plus project, which is planned to be proposed in the future. The JC welcomed the shared information on the project and encouraged further development by working closely with concerned General Directorates and provincial departments under the Ministry of Environment, Cambodia, as well as other concerned stakeholders.

Agenda item 6. Conclusion of the meeting

The Co-Chairs gave closing remarks and closed the meeting.

The JC recognized the importance of the work undertaken by TWG and consented to extend their work, as necessary, for implementing REDD+ projects under the JCM.
