# Joint Committee of the Joint Crediting Mechanism between Senegal and Japan First Meeting

# **Meeting Report**

# Agenda item 1. Opening

Mr. Fode FALL, Secretary General of the Ministry of the Environment and Ecological Transition, the head of the Senegalese side, opened the first meeting of the Joint Committee (JC) of the Joint Crediting Mechanism (JCM) and gave opening remarks, highlighting the cooperation between the two governments; cooperation based on the protection of vulnerable groups, protection of the environment, the fight against climate change among other areas of intervention.

Mr. IZAWA Osamu, Ambassador of Extraordinary and Plenipotentiary of Japan to the Republic of Senegal, Embassy of Japan in the Republic of Senegal, the head of the Japanese side, gave opening remarks, highlighting the quality of Senegalese-Japanese cooperation. Such cooperation covers several areas such as the response to the effects of climate change among others. Indeed, Japan, aiming to reduce its greenhouse gas emissions by 46 to 50% by 2030 (with 2013 as the reference period), has adopted a dynamic cooperative approach to meet its Nationally Determined Contribution (NDC). As a result, the purpose of the Joint Committee meeting constitutes "a major subject" that he would even like to share with the higher authorities of the government during an upcoming hearing.

# Agenda item 1.1 Brief presentation of JCM

The Japanese side explained the overview of the JCM.

## Agenda item 1.2 Rules of Procedures for the Joint Committee

The JC considered the draft "Joint Crediting Mechanism Rules of Procedures for the Joint Committee" including the draft "Conflict of Interest Declaration Form". The point raised focused on:

- the need to include French among the working languages of the Committee;

The element of response to the question is broken down as follows:

- The possibility of translating certain important documents into French is possible. On the other hand, the working language remains English.

After these discussions, the JC adopted them as contained in <u>Annexes 1 and 1.1</u> to this meeting report.

## Agenda item 2. Organizational matters

#### Agenda item 2.1 Appointment of Co-Chairs

The Senegalese side appointed Ms. Madeleine Diouf SARR as the Senegalese Co-Chair, and the Japanese side appointed Mr. HIROSE Shinichi as the Japanese Co-Chair. The Co-Chairs jointly serve the JC of the JCM between Senegal and Japan.

#### Agenda item 2.2 Attendance

The JC consented to the participation of the attendees who were other than governmental officials at this JC meeting based on confirmation of the Conflict of Interest Declaration Forms submitted by the attendees.

#### Agenda item 2.3 Establishment of the JC secretariat

The JC established the JC secretariat. The Japanese side nominated Mitsubishi UFJ Research and Consulting Co., Ltd. to serve as the JC secretariat from the Japanese side. The Senegalese side nominated Mr. Papa Lamine DIOUF, Mr. Pierre SENE and Mr. Bonifece CACHEU, to serve as the JC secretariat from the Senegalese side.

#### Agenda item 2.4 Adoption of the agenda

The JC adopted the agenda of the meeting.

#### Agenda item 3. Rules and guidelines

The JC considered the draft version of the following documents. The points raised focused on:

- the need to align the rules and procedures of the JCM with those currently developed by Senegal as part of its procedures manual;
- regarding the approval of methodologies, the eligibility of international standards, such as Gold Standard (GS), Verra, and Clean Development Mechanism (CDM), should be considered;
- the consideration of sustainable development criteria with appropriate tools is established;
- the need to strengthen the capacity of local actors to better participate in the JCM is

mentioned. This capacity building concerns both the private sector and the members of the JC;

- the possibility, for each government, of creating its own methodology with the related procedures, steps, and standards;
- the possible existence of a Methodological Panel that could support the JC in approving these methodologies was raised;
- the clarification of verification and validation standards and procedures is discussed; and
- the possibility of a Senegalese company applying to become a DOE.

The elements of response to these questions are broken down as follows:

- Currently, the JCM does not allow the use of methodologies of other standards, such as GS, Verra, and CDM;
- The JCM is more conservative and simplified than the CDM and other standards;
- The simplified checklist for Sustainable Development criteria in the Sustainable Development Implementation Plan/Report Forms, which must be reviewed/evaluated by the secretariat and JC;
- Capacity building at the national level and for the Joint Committee members is possible. It will then be necessary to discuss the contents of this training package in depth.
- There is no panel for reviewing methodologies, but a panel can be established if necessary;
- A Senegalese company can apply to become a Third-Party Entity responsible for validation/verification if it meets the criteria described in the Guidelines for Designation as a Third-Party Entity;

## Agenda item 4. Project Idea Note (PIN) of a planned JCM project

The JC considered the Project Idea Note (PIN) of a planned JCM project, SN\_PIN001 "Highefficiency Cookstove Project", which was submitted on 24 April 2024, and decided that it has no objection to the project. The JC discussed the credit allocation proposed by the project participants and recognized that they need to develop a draft methodology and obtain approval from the JC to calculate the amount of credits to be issued. It was decided by the JC to respect the Senegalese procedure currently applied, including the development of a project idea note, the monitoring of a detailed project document and the issuance of authorization. At the end of this process, the JC will discuss the terms of distribution of carbon credits. Furthermore, the JC noted that the no-objection is not an authorization referred to in Article 6.3 of the Paris Agreement.

#### Agenda item 5. Japan's support for the JCM partner countries

The Japanese side explained the financing programmes for the JCM (the JCM model projects, the JCM F-gas recovery and destruction model projects, JCM support programme by the United Nations Industrial Development Organization), the project development and outreach activities. The Japanese side also explained the JCM promotion scheme, the JCM feasibility study, and the JCM demonstration projects.

## Agenda item 6. Other matters

The Japanese side explained the institutional arrangements for the Article 6 implementation in Japan. The Senegalese side shared the status of its institutional arrangements.

#### Agenda item 7. Conclusion of the Meeting

The Co-Chairs gave closing remarks and closed the meeting.
